P2Ps align national strategies, helping to overcome fragmentation of public research effort. P2Ps (ERA-NETs, Article 185, Joint Programming) involve varying degrees of joint effort, such as the co-ordination and integration of national programmes, the implementation of joint calls with EC contribution, and high-level commitment to address a particular societal challenge.
