Strategic Coordinating Process

New governance framework for European Partnerships in Horizon Europe to ensure strategic oversight of the partnership portfolio and evidence-base policy-making

Building blocks:

Programme committee: general information on implementation + identification on new coprogrammed and co-funded partnerships (2nd Strategic Plan)

Partnership Knowledge Hub (launched in October 2021 as EC expert group): working-level interactions between the Commission, EU countries, as well as partnership representatives on issues related to monitoring, mutual learning and foresight.

Stakeholder Forum: regular event bringing together the whole community discussing policy and practical dimensions related to Partnerships.








Partnership Knowledge Hub (PKH)

Composition:

- 31 members (MS/AC, Commission)
- 49 observers (Partnership representatives)
- two co-chairs (DG RTD/ MS (DE))

Partnership Knowledge Hub - Mandate

- Supporting transparency and visibility of partnership portfolio and impacts
- Evidence base (Biennial Monitoring Report (BMR) on partnerships)
- Foresight activities supporting the identification of priorities for possible R&I partnership candidates
- Strategic discussions to ensure strategic steering and political guidance
- Community building and mutual learning across the R&I partnership community (i.e. Annual Forum)







Partnership Knowledge Hub – Working Modalities

- 4 meetings per year (so far mostly virtual)
- (Rolling) Annual Work Plan according to the topics of the PKH mandate, notably
 - Evidence Base (BMR)
 - Foresight
 - Strategic Discussions
 - Community Building
- ,Products'/ Deliverables: Opinions (see BMR opinion), input to BMR, Annual Partnership Forum, etc.







PKH Work Plan 2023

- Working Group to prepare an opinion for the partnerships under the 2nd strategic plan (by March/April 2023)
- Draft first guidelines for the partnerships phasing-out modalities (December 2023)
 - Involvement of stakeholders: Hearing, national coordination process
- Mutual Learning Actions on ,impact measurement frameworks' and ,role of partnerships in national R&I policies'
 - Involvement of stakeholders: to be discussed
- Input to next Partnerships Stakeholder Forum (by Easter 2023)
 - Involvement of stakeholders: Hearing, national coordination process

The Second Strategic Plan – 1/2



- The 2025-2027 strategic planning process for Horizon Europe has been officially launched by Commissioner Mariya Gabriel during R&I Days on 28 September.
- The Strategic Plan 2025-2027 will prepare the contents of the Horizon Europe work programmes for that period
- It will as its predecessor be co-created with Commission services and co-designed with stakeholders
- The Strategic Plan will consider a broad range of perspectives, from emerging Commission priorities, foresight, quantitative data, evaluations and analysis to citizens' insights and ideas
- The process will also include extensive exchanges with the Member States and the European Parliament
- The Strategic Plan 2025-2027 will have as a starting point the Strategic Plan 2021-2024 to ensure continuity and efficiency of the strategic planning







The Second Strategic Plan - 2/2

Main phases:

- Collection of lessons learned and planning of the process
- Collecting data
- Consulting stakeholders with the largest ever public online consultation of Horizon
 Europe. The exercise will be launched in November on *Have your say portal* and will
 remain open for 12 weeks until February 2023.
- Conducting analysis
- Drafting the Strategic Plan in co-creation and co-design
- Interservice consultation, adoption and communication
- Preparation and adoption of the Work Programme 2025











Second Wave of Partnerships

A relatively **small second wave of partnerships** are foreseen and are to be selected based on a set of key parameters :

- Ambitious objectives, EU added value and impacts
- Rationalisation (a limited number)
- Clear contribution to the current EU policy priorities
- Coherence and synergies at EU and national level
- Transparency and openness as well as flexibility of implementation
- Increased level of commitments from partners compared to the current level, in particular private partners
- International positioning









The Strategic Coordinating Process

The process for selecting new partnerships will be done in the context of the Strategic Coordinating Process for European Partnerships.

 Article 6.5. Specific Programme of Horizon Europe: "The strategic planning shall be complemented by a Strategic Coordinating Process for European Partnerships, with the participation of Member States and the Commission on an equal footing. It shall function as an entry point for foresight analysis, analysis and advice on the portfolio development, possible setup, implementation, monitoring and phasing out of R&I partnerships and be guided by a comprehensive criteria framework, based on Annex III of Regulation"













The Second Strategic Plan and the Partnership Knowledge Hub (PHK)



- The selection of European Partnerships is fully integrated in the strategic planning of Horizon Europe, with the Strategic Configuration of the Horizon Europe Programme Committee as the single-entry point for the structured and early consultation of Member States and Associated Countries.
- The preparatory work for the consultation will be done by the Partnership Knowledge
 Hub that is expected to provide advice on foresight activities supporting the identification
 of priorities for possible new R&I partnership candidates of European relevance, advise
 on potential new partnerships for the second wave, and thereby facilitating discussions
 in the Horizon Europe Strategic Programme Committee.
- This exercise has been launched at the 4th PKH meeting that took place on 4 October 2022 with the launch of PKH ad-hoc Working Group, composed of Germany, Netherlands, Estonia, France, and Austria.
