



New approach to European Partnerships

New generation of objective-driven and more ambitious partnerships in support of agreed EU policy objectives

Key Features

- **Strategic orientation**
- **Simple architecture and toolbox**
- **Common set of criteria for the life-cycle (Horizon Europe regulation Article 8 and Annex III)**

CO-PROGRAMMED

Based on Memoranda of Understanding/contractual arrangements; implemented independently by the partners and by Horizon Europe

CO-FUNDED

Based on a joint programme agreed and implemented by partners; commitment of partners for financial and in-kind contributions

INSTITUTIONALISED

Based on long-term dimension and need for high integration; partnerships based on Art 185/187 of TFEU and the EIT legal acts for 2021-2027

Co-funded European Partnership

- Relevant **current actions**: European Joint Programme and ERA-NET Cofund;
- **Legal form**: Grant Agreement (programme co-fund action) signed between a consortium of beneficiaries and the Commission;
- **Implementation**: Member States design a common programme to be implemented under their responsibility. It pools national funding/resources with co-funding from the Union.
- **Estimated EU contribution to the 16 co-funded partnerships**: EUR 2.2 billion
- Calls and evaluations are organised centrally, beneficiaries in selected projects are funded at national level
- **Important to** define ex-ante:
 - Types of partners needed to form the partnerships (consortium);
 - Stakeholders providing input (e.g. priority setting) ← **role of ministries!**
 - Stakeholders and target groups that are addressed/ involved by the activities implemented.

Co-funded European Partnerships - Key principles

- EU co-funding is at a constant rate [typically 30%, in exceptional cases 50%] per grant agreement and is generated by eligible costs
- Each consortium agrees internally on how the EU cofunding is best used / distributed internally (similar to ERA-NET Cofund / EJP Cofund actions in Horizon 2020)
- To create eligible costs for co-funding, the financial management of co-funded European Partnerships will be in line with the rules for financial management for any Horizon Europe action.
- This applies to all contributions, including cash contributions (in Horizon 2020 they were listed under cost category financial support to third parties)
- All Co-funded European Partnerships will have corresponding topics in the Horizon Europe work programme

Strategic Coordinating Process: Political context

The Council has insisted on creating strategic coordinating process for partnerships since 2017. The rationale is to ensure the early involvement of Member States in the preparation, implementation and strategic oversight of partnerships, to make sure that the new principles are being applied, and to maximise the impact of joint investments made through partnerships.

Key political documents regarding the Strategic Coordinating Process (in chronological order)):

- [Council conclusions](#) “From the Interim Evaluation of Horizon 2020 towards the ninth Framework Programme” (2017)
- [ERAC recommendations](#) on the requirements for the set-up of a strategic coordinating process for the selection, implementation, monitoring and phrasing out of R&I partnerships (based on **ERAC Ad-hoc working group on partnerships, 2018**)
- **Article 4a of the draft Horizon Europe [Specific Programme](#)**: “*The strategic planning process shall be complemented by a **strategic coordinating process** for European Partnerships, with participation of Member States and the Commission on equal footing. It shall function as an entry point for foresight analysis, analysis and advice on the portfolio development, possible setup, implementation, monitoring and phasing out of R&I partnerships and be guided by a comprehensive criteria framework, based on Annex III of the Horizon Europe Regulation.*”
- [Transitional Forum for R&I Partnerships](#) to prepare for the launch of the Strategic Coordinating Process in 2021
- [Council Conclusions](#) on the New European Research Area (2020): “Calls on the Commission to ensure the timely launch of the Strategic Coordinating Process for Partnerships.”

Strategic Coordinating Process for Partnerships: Objectives

The overall goal of the strategic coordinating process is to support an evidence-based policy for partnerships and a strategic vision of the landscape. It should allow a consolidated view on the progress made by partnerships.


Concretely it aims to:

1. Support **Community Building** and mutual learning across partnerships;
2. Raise **Visibility** and strengthen stakeholder communication and consultation;
3. Provide policy makers and partnerships with the **Evidence Base**;
4. Prepare **Strategic Discussions** on key policy issues;
5. Ensure a **Feedback Loop** from Member States and Partnerships on the portfolio evolution, implementation, monitoring and evaluation.


→ The achievement of these 5 objectives will be driven by the Partnership Knowledge Hub!

Strategic Coordinating Process for Partnerships: Different elements

- The monitoring of European Partnerships and other R&I partnerships of European relevance will be a main visible output of the Forum.
- [Independent expert group](#) (Jan 2021 – June 2021)
- Implemented via COM informal expert group (TBC)




Independent Expert Group (E03738) in support of strategic coordinating process: objectives



European Partnerships – drivers for synergies

- Horizon Europe expects partnerships to take a “**systemic approach in the achievement of the objectives**”, including “**to ensure coordination with other relevant R&I initiatives**”.
- Coordinated preparation of Partnerships → **Allows to agree collaborations and synergies ex ante**
- June-October 2020: [mapping of coherence & synergies](#) → agreement on priorities within / between clusters
- The final agreements will be reflected in the **Strategic R&I Agendas**
- New opportunities for using Cohesion policy funds in co-funded and institutionalised partnerships (HE Article 11).

Proposal submission & evaluation

- **Call topics** for programme co-fund actions for the implementation of the Co-funded European Partnerships included in the Horizon Europe Work Programme 2021/2;
 - All topics will have a close date of publication (foreseen right after the adoption of the WP)
 - All topics will have close deadlines for call closure (minimum three months after call publication)
- **Submission** of proposals in 2021 (2022), launch of partnerships with signature of Grant Agreement (submission plus 8 month).
- The **evaluation** of all co-funded European Partnerships will be organized jointly
 - A number of horizontal, partnership experts will be contracted to evaluate each co-funded European Partnership – to ensure consistency across actions
- Q4/2021: **launch** of co-funded European Partnerships (signature Grant Agreement with a consortium of national research funders)
- In duly justified cases it is possible to have retroactive / fixed starting dates


- Templates still in preparation – official launch the same time as the Work Programme publication
 - Reporting templates (Project Officer report)
 - Proposal templates, Annual Work Plan template
 - Newer / additional elements if needed
- Official guidance and more details will be published in the Annotated Grant Agreement
- Annual Work Plan
 - First Annual work plan is submitted together with the proposal
 - Every consecutive year a new Annual Work Plan is submitted to the Commission / Executive agency
 - The yearly Annual Work Plans are accepted by the Commission / Executive agency and the consortium continues their work

European Partnerships: monitoring criteria

- a) *A monitoring system in line with the requirements set out in Article 45 to track progress towards specific policy objectives, deliverables and key performance indicators allowing for an assessment over time of achievements, impacts and potential needs for corrective measures;*
- b) *Periodic dedicated reporting on quantitative and qualitative leverage effects, including on committed and actually provided financial and in-kind contributions, visibility and positioning in the international context, impact on research and innovation related risks of private sector investments;*
- c) *Detailed information on the evaluation process and results from all calls for proposals within partnerships, to be made available timely and accessible in a common e-database.*

Beneficiaries which are receiving financial support to third party – Conflict of interest avoidance

In case a direct beneficiary to the signed co-funded Grant Agreement also applies to calls to third parties organized by the partnership (i.e. in case a beneficiary is both research funder and research performer):

The consortium should implement all points below:

- The consortium should identify the beneficiaries which might apply for funding under the co-funded call for proposals
- The consortium should explain the measures taken or to introduce additional measures to mitigate the risk of, perception of, or de facto conflict of interest or unequal treatment of applicants
- The consortium should reflect all these measures fully in their description of activities for the preparation and implementation of the co-funded call as well as in relation to the monitoring of the trans-national projects
- These measures should be implemented by demonstrating that information is kept non-accessible to other members of the consortium (or the departments concerned, in case a beneficiary is both research funder and research performer) that might apply to the co-funded call
- These measures should include a procedure, which ensures the independent and fair treatment of complaints related to the call, in particular for complaints relating to unequal treatment of applicants



Setting up the consortium

Use your SRIA to define criteria for partners



Do not hesitate to analyse what exists = is relevant = you want it on board



If needed, use Letter of Intent and Letter of Commitment obligation (for partners & LTPs)



Make sure that in the choice of your partners you DO NOT forget representatives of society/patients and ensure relevant representation of EU13 countries




To officialise the process, if possible, ask for support of the European Commission → sending of information to national representations in Brussels

As the future coordinator, make sure you have relevant support from your respective ministry and Programme Committee representative → they will be key in negotiations

If the selection of partners is not top-down (directly proposed by the ministries) set up a "selection committee" composed of experts that will help you in evaluation of relevance of applying institutions



Governance



- Keep it simple and define clear distinction of responsibilities between different bodies (GA, ExCom, Operating Group)
- If not involved directly, get engage with policy makers (ministries, EC, representatives of industry and society) through an external body → Policy Board + National Mirror Groups
- If implementing open calls for projects make sure to have a “fire-wall” process and independent Board of Funders and Scientific/Advisory Board
- Make sure that you have a transparent decision-making process, even if sometimes it may require “procedural” validation (the coordinator should not decide in the name of the consortium)

Management

🌈 Depending on the size of the consortium, a **highly qualified coordination team** is key! → make sure that it includes people with good knowledge of: project management, financial & administrative, communications, ethics & regulatory and the topic of your partnership

e.g. EJP RD currently involves over 130 institutions, which translates to 1200 people working on the programme. We have 5 project managers, 1 financial/administrative officer, 1 communication officer, 1 project assistant – all FULL TIME!

🌈 **Equip yourself with central management system** (e.g. MS Teams) to be able to share & work on documents centrally and in secure manner, organise conferences, launch surveys, workshops, etc.

🌈 **Clear procedures/processes & support** is needed to ensure efficiency and transparency. Creation of dedicated toolboxes (e.g. for calls for project), training materials for partners (e.g. for financial issues or central management system, use of available tools) and rules that apply to all partners (e.g. good practices for travel costs, organisation of events, publications) are helpful for smooth management and also create a pool of references for everybody.


🌈 **Be efficient in...waiting:** applying changes, initiating new collaborations requires validation (of GA/EC/institutional administration/etc.) → **be aware of the time** these procedures take to include it in your planning and activities + **facilitate** as much as possible their advancement.

🌈 **Be prepared** for lots of administrative work (that never stops): only the preparation of the annual technical & financial report and annual work plan take several months within a year. In addition, big consortia and relative flexibility of the partnership instrument may induce regular need for amendments!

🌈 **Set aside budget** dedicated to cover the **costs of independent ethics/regulatory advisor** that accompanies the project



EJP RD - lessons learned



MANAGEMENT

Central project management/collaborative platform (e.g. MS Teams)

FINANCIAL/ADMIN:

Internal reporting & verification process by CoO in advance of submission to the EC

GOVERNANCE

Keep good interaction with your General Assembly. Make sure that you engage MS and other stakeholders through dedicated bodies (Policy/Stakeholders Board, National Groups)

FUNDING

Avoid internal calls (foster good definition of activities & share among partners)
If cannot be avoided, make sure that it is managed by partner experienced in management of open calls (e.g. funding agency)

BUDGET

Weight pros and cons of applying different reimbursement rates: it is burdensome BUT it allows on more flexibility & implementation of activities that cannot be financed by in kind contributions

- Activities must be defined & agreed in the Annual Work Plan and the signed Grant Agreement
- For the cost for financial support to third parties to be eligible, all call conditions need to be followed

Eligible costs – conditions

No matter their nature, all costs have to comply with the Model Grant Agreement eligibility rules:

- (i) they must be actually incurred by the beneficiary
- (ii) they must be incurred in the period set out in Article 4 (with the exception of costs relating to the submission of the final periodic report, which may be incurred afterwards; see Article 21)
- (iii) they must be declared under one of the budget categories set out in Article 6.2 and Annex 2
- (iv) they must be incurred in connection with the action as described in Annex 1 and necessary for its implementation
- (v) they must be identifiable and verifiable, in particular recorded in the beneficiary's accounts in accordance with the accounting standards applicable in the country where the beneficiary is established and with the beneficiary's usual cost accounting practices
- (vi) they must comply with the applicable national law on taxes, labour and social security and
- (vii) they must be reasonable, justified and must comply with the principle of sound financial management, in particular regarding economy and efficiency

Co-funded Partnerships Synergies with Cohesion Policy funds

Maria Bianco (ERA-LEARN)



Creation of pre-condition and ecosystem facilitating the participation in a EP or when it provides resources for follow up of funded projects through EP calls



Supporting a parallel or complementary activity related to EP funded projects.
HE Regulation Art.15(4)
CPR Art. 21



Cohesion policy funds are used within the work plan of a EP and counts as a partner/national contribution.
HE Regulation Art.15(3)

Alignment of S3 is fundamental for maximizing the Cohesion Policy funds impact

HE Regulation Art.15(3)

“Alternative, **combined**, cumulative funding and transfers of resources” :

“Financial contributions under programmes co-financed by the **ERDF**, the **ESF+**, the **EMFF** and the **EAFRD** **may be considered as a contribution of the participating Member State** to European Partnerships under points (b) and (c) of Article 10(1) of this Regulation, provided Article 106 and other applicable provisions of Regulation (EU) Common Provision Regulation...+ and the fund-specific regulations are complied with.”

A country participates in a call launched by a consortium of National Funding Bodies in a co-funded European Partnership.

It participates with a programme/priority that is co-financed by the ERDF (e.g. 50% national funds and 50% ERDF for this priority).

The National Funding Body reports the costs of providing financial support (funding paid to its beneficiary) with a value of € 100 to Horizon Europe, and receives a funding of 30% from Horizon Europe;

The remaining 70% could be paid out of the cohesion programme/priority :

- **30% Union funding from Horizon Europe**
- **35% national funding**
- **35% Union funding from ERDF**

Co-funded European Partnerships with in-cash contributions from cohesion policy funds to finance projects resulting from joint calls for transnational proposals:

- Funding rules of the participating operational programme apply for the regional/national contribution;
- Horizon Europe contributions is transferred via coordinator to managing authority and used as a additional funding for the projects resulting from the calls;
- Eligible costs of funding the projects are reported to COM, and reimbursed.

Co-funded European Partnerships with in-kind contributions:

- Partners (beneficiaries in the programme co-fund action implementing the European Partnership) carry out activities;
- Eligible costs of implementing activities are **reported and partially reimbursed** by the Horizon Europe contribution;
- The non-reimbursed costs can be covered by an **operational programme**.

(also possible with cumulative synergies)

Integrated Synergies and State Aid regulation

Under the conditions specified in Articles 25c or 25d of the draft GBER-amendment, **co-funded research and development projects may benefit from Horizon Europe eligible costs and funding rates**

-> no need to be subject to a separate State aid assessment and notification.

The GBE Regulation should be approved on June 2021 with retroactive effectiveness.

- **Open dialogue with European Partnership consortia:** Managing Authorities and National/Regional Stakeholders should identify R&D priorities in compliance with S3 priorities and planning of appropriate cohesion policy funds measures;
 - Joining consortia in planning phase. Two options for including regional actors:
 - § Formal partner that contributes to the partnership (beneficiary in the grant agreement)
 - § “associated” to certain activities (triggered by the partnership) without being a formal partner
- **Align** national and regional **Smart Specialization Strategies (S3)** and include **provisions in OPs** that enable parallel/alternative and complementary funding among different EU and national programmes;
- Coordinate with **National representatives** for coordinating national and regional commitments to European Partnerships to join

Practical use of EC funding: concept of internal arrangements

Co-funded European Partnerships: financial management in practice

- the total EC contribution will be calculated as a percentage of the **total eligible costs**
 - to **create eligible costs for co-funding**, the financial administration of a co-funded Eur. Partnership must comply with the EC rules for any Horizon Europe action.
 - each **consortium agrees internally** on how the EU contribution is used best and distributed internally -same principle as for Horizon 2020 ERA-NET Cofund and EJP Cofund actions!
 - each consortium agrees on the **allocation of the EC contribution to each activity and beneficiary** (which can result in an unequal distribution to beneficiaries/activities).
- **Recommendation: Keep it simple!**




Cofunded calls: allocation/distribution of EC funding

- The total EC contribution is calculated as a percentage of the total eligible costs.
- Therefore, if the actual eligible costs are for any reason lower than the foreseen amount defined in the GA, the **EC contribution will be reduced accordingly**.
- In order to ensure full use of the EC contribution in individual calls and for all calls collectively, the consortium needs to ensure **sufficient reserve amounts** for national call contributions (H2020 experience: around 20%).
- Since the response to a transnational call is unforeseeable (depending on the success of national applicants in calls) and the ranking list needs to be followed according to the EC rules, it is in the interest of all consortium members to **agree on a flexible distribution of the EC contribution**.
- **Mixed funding mode**: a part of the call budget is used as a virtual pot while another part is used as a real common pot. The mixed mode has proven to be instrumental in following the ranking list.

Balancing budgets: avoid unused funding

joint call without EC cofunding available for gap-filling:

- oversubscribed vs undersubscribed national budgets
- example: only 61% of the total available national/regional funding could be used because of unbalanced budgets
→ could be avoided with flexible gap filling

Cofunded calls: allocation/distribution of EC funding

- rules laid down in Annex 5 to the Model Grant Agreement (e.g. selection procedure and criteria: calls open 60 days, Horizon Europe selection criteria, single trans-national call, two-step procedure, measures to avoid potential conflict of interest, ranking according to evaluation results, independent observer)
- the consortium decides on the allocation of the EC top-up funding

Example: **flexible allocation of EC funding for efficient filling of gaps in ranking list** → variety of funding rates

Practical experience: funding modes

mixed mode (most frequent case):

- lot of experience -used by the majority of ERA-NET Co-fund networks
- part of the available EC top-up (typically 30-50%) used as a “**balancing pot**” for gap filling; some networks even increased the percentage for balancing purposes to **fund as many projects as possible** from the ranking list; the rest allocated to funding organisations based on a fixed percentage
- the consortium decides which proportion is likely to **deliver the most convenient result** (=max. number of funded proposals AND individual return)
- mixed mode enables national/regional programme owners to retain substantial autonomy and **control of their own national/regional budgets** and funding decisions while a part of the budget is dedicated to **funding the proposals with the highest quality**.

real common pot (rare):

- used by a few ERA-NET Co-fund networks –delivers **longest selection list**
- no fixed individual return rate, could be 0%

fixed return (rare):

- fixed percentage of top-up funding for each national budget
- still **substantial risk** in the ranking list -small budgets will still be small budgets/bottlenecks even with EC top-

**concept of internal arrangements:
other joint activities**

Other activities: internal allocation/distribution of EC funding

- EU funding is at a constant rate [typically 30%, in exceptional cases 50%] per grant agreement and is generated by eligible costs (joint calls and other **activities described and agreed in GA and annual work plan**)
- a consortium can decide to allocate the EC contribution to the planned activities differently which can result in **different funding rates for different activities.**
- Example:

- **But: different internal funding rates for different activities will increase the complexity → management efforts will be higher**
- **Recommendation: Keep it simple!**



Co-funded calls – Criteria, procedures I

When implementing financial support to third parties in Co-funded Partnerships, the beneficiaries must respect the following conditions:

- **avoid any conflict of interest** and comply with the principles of transparency, nondiscrimination and sound financial management
- for the types of activity and categories of persons that will be supported:
 - for multi-beneficiary projects (including multi-participant projects): the projects supported must be transnational, involving at least two independent legal entities from two different EU Member States or associated countries as recipients of the financial support and may also include legal entities established in a non-associated third countries not receiving financial support
 - for mono-beneficiary projects (multi-participant projects): the projects supported must be transnational, involving one legal entity established in an EU Member State or associated country as recipient of the financial support and one legal entity established in a non-associated third country not receiving financial support

Co-funded calls – Selection Procedure & Criteria I

- **publish** open calls **widely** (including on the Funding & Tenders Portal and the beneficiaries' websites)
- keep **open** calls open for at least **two months**
- **inform** recipients of call updates (if any) and the **outcome of the call** (list of selected projects, amounts and names of selected recipients)
- **measures to avoid potential conflicts of interest** or unequal treatment of applicants must be ensured (notably through appropriate communication / exchange of information channels and independent and fair complaints procedures)
- use the following selection criteria: the standard Horizon Europe award criteria (**Excellence, Impact** and **Quality and efficiency of the implementation**)

Co-funded calls – Selection Procedure & Criteria II

- use the following selection procedures:
 - projects must be selected following **joint transnational call(s) for proposals**
 - beneficiaries must make the selection through a **two-step** procedure:
 - Step 1: review at **national** or transnational level (including national eligibility checks)
 - Step 2: single **international peer review** (standard Horizon Europe award criteria)
 - and in Step 2:
 - proposals must be evaluated with the assistance of at least **three independent experts**
 - proposals must be **ranked** according to the **evaluation results** and the selection must be made on the basis of this ranking
 - the selection procedure must be followed by an **independent expert observer**, who must make a report.

Co-funded calls – Data management / data structure I

- All European Partnerships will need to establish a monitoring system that can track progress towards objectives, impacts and key performance indicators. (Horizon Europe legal base)
- In order to simplify and standardise this at the level of the individual projects funded by the partnerships , the **data on proposals, selected projects**, their outcomes and results will need to be **integrated in the central IT** tools (eGRANTs Data Warehouse, dashboard).
- It will require that co-funded European Partnerships under Horizon Europe **develop / adjust** own (central) IT tools **to common data standard**, ensure that IT tools are fit for purpose, and run a pilot programme prior to the launch of the first call.
- Our **team will contact all co-funds** to be started Q4 2021 / Q1 2022 to present the current version of the IT solution and support implementation of data transfer pilot

Co-funded calls – Data management / data structure II

- The data structure contains, for each call launched under a co-funded European Partnership
 - Detailed proposal level information
 - More detailed project level information
 - Each participant will need to have a Horizon Europe PIC (temporary PIC accepted)
 - Some additional fields to ensure coverage of the Key Impact Pathways
- Data exchange to be done automatically (not using XLS files) once the interface between the databases at Commission and co-funded European Partnership level is set up
- Data exchange will include automatic data quality checks – incorrect data will not be accepted

Other Additional Activities

Next to the activities described in the sections above, there are a number of other additional activities carried out in the European Partnerships that might be relevant for the implementation of their work programmes. ERA-LEARN introduces some examples and good practices for these activities.

Knowledge sharing using Databases, Hubs, Platforms & Infrastructures

Knowledge sharing is of an utmost importance for the vitality and successful co-operation of partnerships in the European landscape in the future. By now, the past and ongoing partnerships have already formed different kinds of knowledge networks, databases and hubs to intensify the flow of information around their thematic neighbourhoods and more broadly. For collaboration, specific platforms or infrastructures have been built. Existing examples are collected (by ERA-LEARN) under the link above, to be complemented by new ones.

Mapping exercises and policies

Before the formation of e.g. a database or platform, mapping exercises are usually needed first. Similarly, for the dissemination of jointly agreed guidelines, preparation of a policy paper is a valued practise. Some examples are found here.

Events for Networking

Meetings within the own network or between different actors on the same/nearby thematic area is needed to be better achieve the set targets. When the face-to-face type meeting and networking has been recently challenged, virtual events has become a more usual practise. Some past events for networking has been collected here. Partnerships are invited to disseminate here information about their meaningful future possibilities as well.

Support for internationalization

In order to tackle global challenges adequately, international collaboration between countries both in and outside of Europe is essential, and partnerships are ideal for its' manifestation through their joint calls. Here, some Joint Programming Initiatives report about their strategies and mapping exercises for collaboration with countries outside Europe.

Prizes and Training

One possibility to increase the visibility of eminent persons in the field or encourage early career researchers/innovators, is to launch prize competitions. This can be issued within one thematic field or by crossing borders. Here is shown an example of the best publication prize and how the award ceremony can be linked into a larger context of the community.

Furthermore, in the methodology intensive fields, continuous methodological training with new techniques is crucial. By pooling resources, trainings can be organized in collaboration with other actors in the field. Organized courses or workshops also serve as optimal events for networking.
